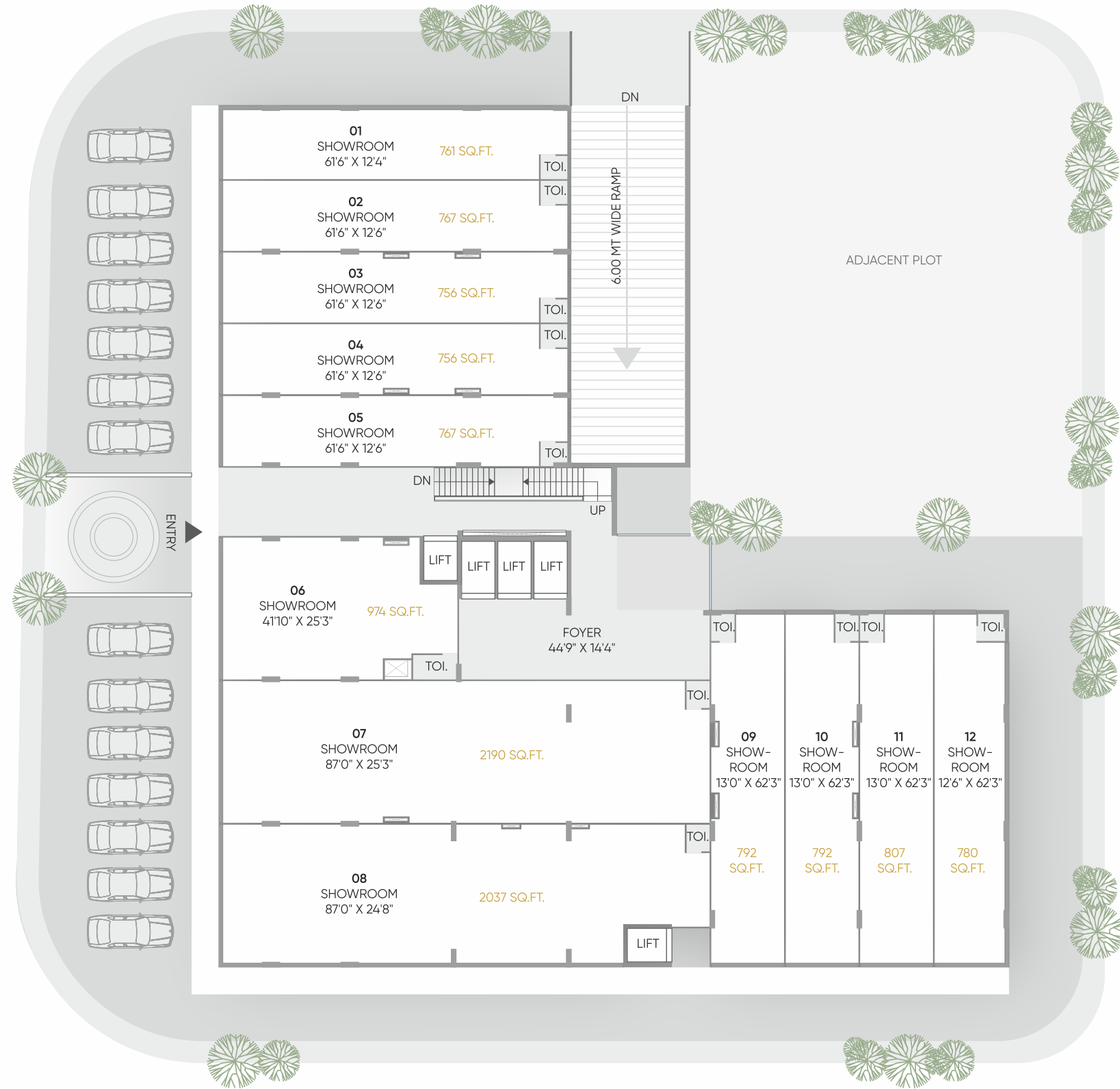

GROUND FLOOR LAYOUT

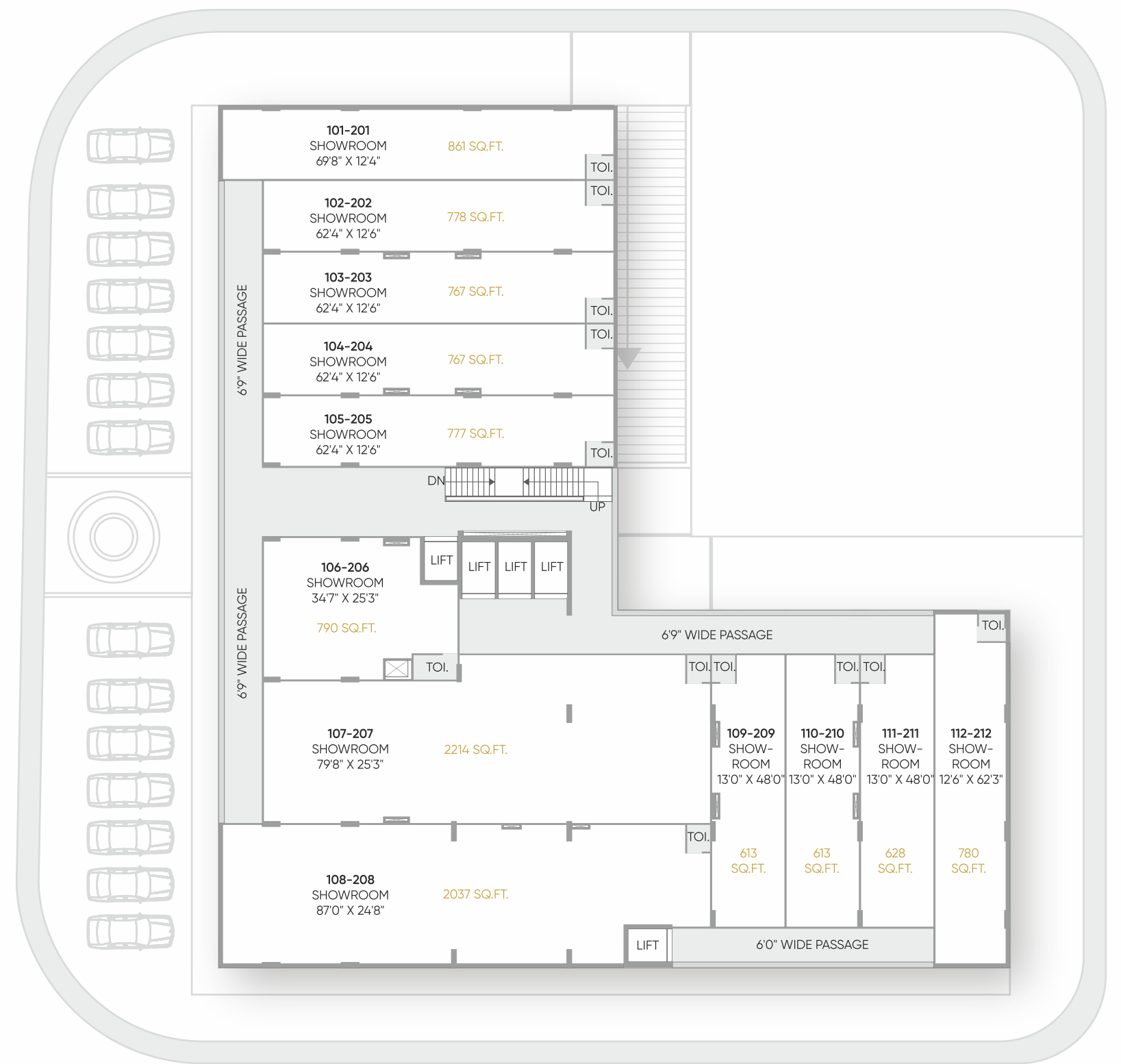

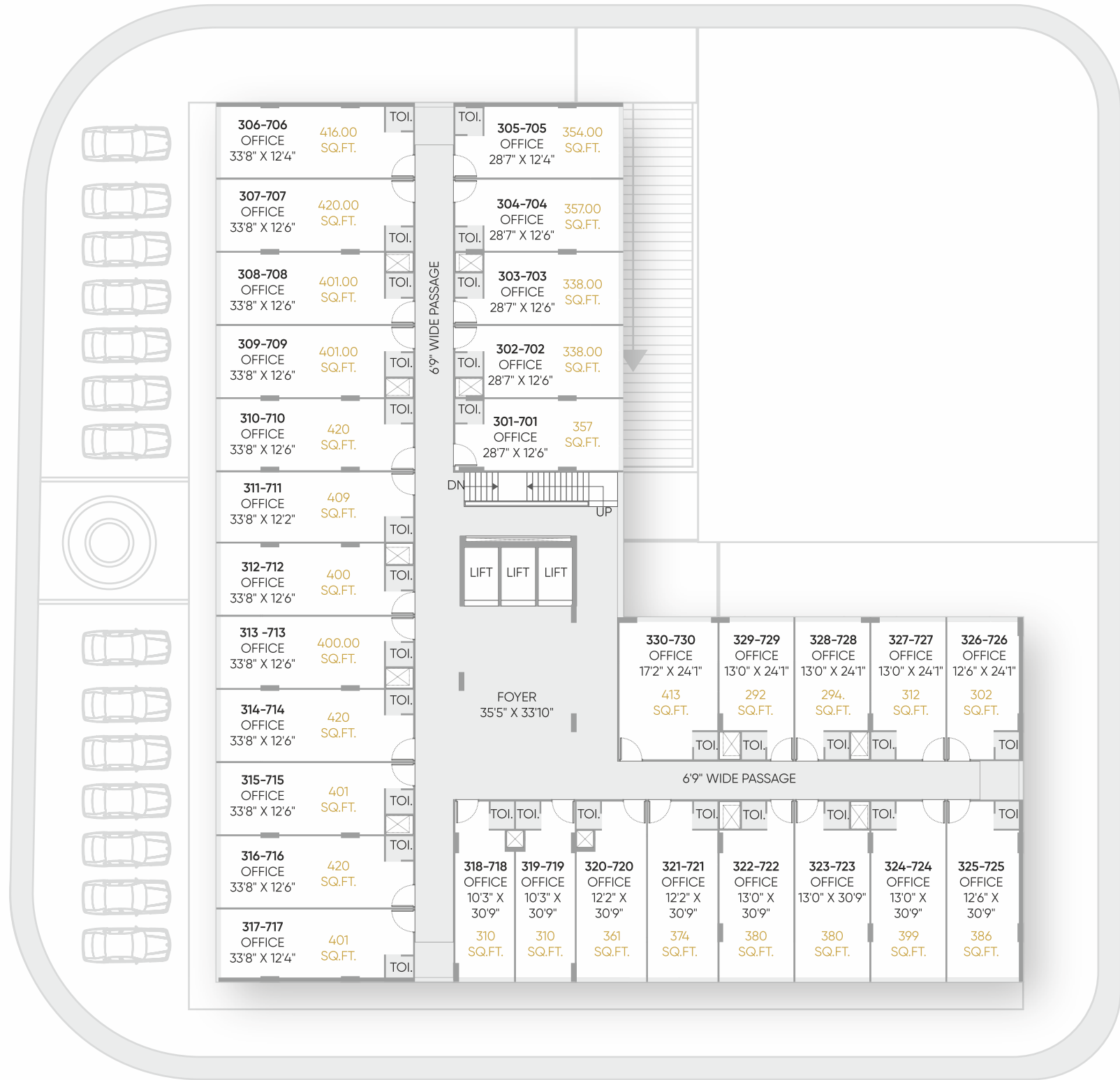

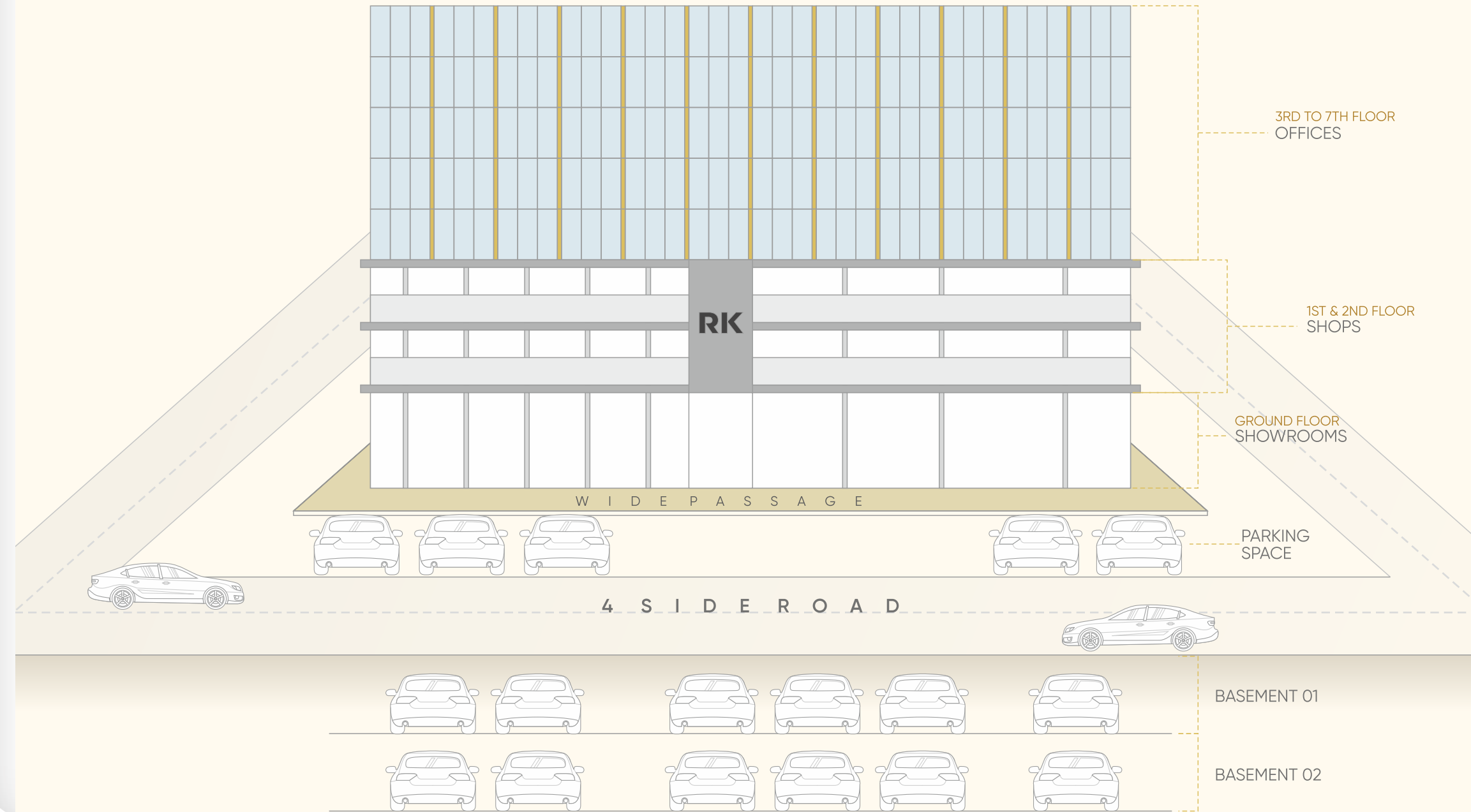
